3. A new UKON ID number will issue for first time or repeat purchase.
4. If UKON DD not repeat more than three times will be terminate, if you purchase three Ukon DD will not be canceled.
5. After terminate, the applicant is not qualified to receive commission for any Ukon DD sales.
6. Once you discontinue, you will not be qualified for SP and your commission will depend on your last direct machine sale.
7. Three (3) Ukon DD sales will count as one machine sale in regards to the incentive bonus.
8. The recipient of an international shipment may be subject to such import fees, GST or VAT which are levied once a shipment reaches your country, additional charges for customs clearance must be borne by the recipient. Custom policies vary widely from country to country; you should contact your local customs office for further information.
